



Contest terms and conditions - ZONTA District 27 Conference - DIAMOND RALLY (Leuven, 1 - 2 October 2021)

Organization - General

These terms and conditions apply to the Diamond Rally, hereafter referred to as "the Rally".

The contest is organized by Zonta District 27, more precisely Zonta Club Leuven and Zonta Club Brussel Zavel on the occasion of the District 27 Conference 2021.

These rules include the terms and conditions for participation in the contest and the course of the contest.

Acceptance of the contest rules

By participating in the contest, the participant declares to have taken note of these contest terms and conditions and declares to agree with and accept them.

Duration

The contest starts on Friday, October 1 (at the screening of the first video) and ends on Saturday, October 2 (with the tie-breaker question being asked). The results will be announced "live" on Sunday, October 3, 2021 before the closing of the Conference.

Who can participate

All registered participants of the Zonta District 27 Conference 2021 can participate, with the exception of the members of the organizing clubs Zonta Club Leuven and Zonta Club Brussel Zavel, as well as the governor and the secretary of the Zonta District 27 Board.

A participant can participate in the competition once. Participating more than

allowed will result in the total exclusion of the participant from the contest.

Match progress

The contest consists of 4 parts (videos), spread over Friday 1 October and Saturday 2 October. A total of 4 short video about the host cities Leuven and Brussels will be shown. At the end of each video a question is asked; after the 4th and final question, there is a tie-breaker question.

The videos are shown only once and cannot be watched again.

Valid participation

The answer to the four *multiple choice* questions and the tie-breaker question must be entered on the answer sheet. The electronic link to the answer sheet will appear on the Conference site on Friday, October 1, 2021

Response forms need to be submitted no later than Saturday, October 2, 2021 at 4 pm CEST.

In order to participate validly and thus have a chance of winning one of the prizes, the participant must correctly follow the course of the contest.

Privacy policy - Use of data

Regarding the use of personal data and the privacy policy, reference is made to the GDPR statement on the Zonta District 27 website (<https://zonta-district27.org>).

Participants in the competition agree by their participation that, should they win a prize, they can be mentioned by name and Zonta club at the Conference and on the Conference site.

The prizes

The winners will be rewarded with one of the following prizes:

The 1st prize is a pink gemstone, donated by the jewellery company "Diam Arts" from Herent-Winksele.

The 2nd prize entitles the holder to one night with breakfast for 2 persons at hotel The Dominican in 1000 Brussels, rue Léopold 9.

The next 100 winners will be rewarded with a "conference goodie box". All prizes will be sent to the winners free of charge.

The prizes cannot be exchanged or converted (e.g. into cash or another prize).

The winners

The winners will be designated by the jury composed of members of the organizing clubs.

Those who answer all the questions correctly will qualify for one of the prizes.

In case of a tie, the participant who comes closest to finding the correct answer to the tie-breaker question will be designated the winner of prize 1, and the participant who comes second to finding the correct answer to the tie-breaker question will be designated the winner of prize 2.

In case of a tie, the participant whose answer sheet was registered first wins.

The remaining participants, limited to 100, will be ranked according to the number of correct answers to the four questions and the answer to the tie-breaker question. They will be rewarded with a conference goodie box.

Announcement

Winners will be notified by email after the contest closing.

The jury - Fraud and abuse

The organizing committee of the Zonta District 27 Conference supervises the correct running of the contest. However, the committee will not accept any disputes relating to the wording and/or interpretation of the contest rules and/or any questions within the framework of the contest.

The decisions of the committee and the results are binding and irrevocable. They cannot be contested. No correspondence (by letter, e-mail or phone) about the results and/or the course of the competition can be entered into with Zonta District 27 and/or the organizing committee.

Participants who in any way manipulate or fraudulently increase their chances of winning may be excluded from participation.

Liability of Zonta District 27

Zonta District 27 is not responsible for any possible damages, losses, bodily injuries or accidents that may occur as a result of winning a prize and/or participating in the contest.

Zonta District 27 is not responsible for not being able to deliver a prize, if the participant did not provide sufficient, incomplete or wrong contact information. Nor is Zonta District 27 responsible for any defects of the postal services and/or courier companies (e.g. delay, damage, strike or loss) in the delivery of a prize.

If a technical incident or Force Majeure should disrupt the progress of the contest, the organizing committee will do everything in its power to neutralize the disrupting effects. Zonta District 27 cannot be held responsible for any damage caused by Force Majeure or technical incidents. Neither can Zonta District 27 be held responsible or liable for any defect in the prize or if the prize does not meet expectations.

Disputes

The organizing committee and the participant shall attempt to resolve any disputes relating to this contest or the interpretation of the terms and conditions in an amicable manner. If they fail to reach an agreement, the dispute must be submitted to the competent courts of the jurisdiction of Leuven, Belgium.
