Venue, date & opening hours

Stone & Tile is being held in Hall 8 of Flanders Expo Ghent, from Thursday 17 to Friday 18 March 2022. The trade fair is open on Thursday and Friday from 9:00 am to 18:00 pm.

Participants-exhibitors and visitors

Participants

Exhibitors at Stone & Tile are Manufacturers, importers, agents and distributors of products, technologies and services whose activities involve natural stone, ceramics, quartz composite and/or concrete. The participants have to use the enclosed registration form to indicate the type of products and brands they shall be exhibiting or services in which they will participate at Stone & Tile 2022. Your registration via the registration form is binding. The only criterion that applies is the fully completed official registration form via the separate document in PDF. The organizer will automatically contact the exhibitor in case of any irregularities. After official registration, the exhibitor will be given access to the online exhibition manual, which contains all practical and technical information regarding participation. It is also possible to place orders via the exhibition manual, which may incur additional costs. The order via the online exhibition manual is considered a binding agreement. The exhibition manual can be accessed via <https://rrst.expodoc.com/>.

Visitors

The event is open solely to professionals whose activities are focused on natural stone, ceramics, quartz composite and/or concrete, not to private individuals. All visitors are invited by the organisation and by participating exhibitors through various off- and online channels. Every visitor can register online in advance via www.stone-tile.be to visit the fair free of charge.

Rental prices of stand placements

All registrations shall be made in accordance with one of the 4 fixed stand modules that are indicated on the registration form: module A=16m² (€3.250), module B=24m² (€4.750), module C=32m² (€5.950) or module D=64m² (€11.500). Prices are VAT excluded. The price includes: assembly and disassembly of stand structure of 2,5 metres height, furniture (table & chairs), electrical connection, multiple socket outlet, spotlights, daily cleaning, Wi-Fi, catering of food and drinks, carpet with protective film, and leadscan system. These items are dependent upon the module or modules reserved by the exhibitor. The price is valid for each integral stand module and/or brand! Stands and/or brands that together exceed 64m² are not cumulative toward the total and remain separate modules with a maximum area of 64m². In no case will there be any exceptions made by the organisation.

Payment

After official registration, the exhibitor will receive the invoice for participation in Stone & Tile. This is done by default 1 month after registration. Payment of all invoices resulting from participation in Stone & Tile has a payment term of 8 days and must be completed before the fair opens. This is the only way for the organisation to guarantee a smooth stand construction. If payment has not been received before 01/03/2022, the organisation can deny a participant access to the stand. Cancellation

Should the rented area be cancelled before the opening of the trade fair or in the event of a failure to show up during the trade fair, the entire rental price has to be paid. Advance sums that are paid cannot be refunded. The cancellation should be notified in a registered letter and/or by email. The Bruges courts have sole territorial competence in the event of a dispute. If the event cannot continue in case of force majeure Corona, the participation fee will be entirely refunded by the organizer.

Occupation and evacuation of exhibition areas

Exhibition areas may be occupied for stand design and layout purposes on Wednesday 16/03/2022 from 08.30 am to 22.00 pm. The stand and decoration have to be completely finished by Thursday 17/03/2022 at 9.00 am. It is not allowed for exhibitors to make the stand, panels or related publicity higher than 2.5m and/or to place items outside the reserved area. All materials should be removed from the stand on Friday 18/03/2022 from 18.00 pm to 24.00 pm and/or Saturday 19/03/2022 from 8.30 am to 12.00 am. Exhibitors displaying heavy machinery are entitled to commence entering their stand on Tuesday 15/03/2022 from 12.00 am, provided they have sought permission in writing beforehand!

Infringements

Should the aforementioned conditions be infringed, the organisers shall be entitled to refuse the exhibition area that has been promised and paid for in advance. Should the stand already be established and arranged, the trade fair organisers shall be entitled to have this stand removed immediately at the expense of the party infringing the aforementioned conditions, without the participant-exhibitor being entitled to compensation or to have the sums paid refunded.
